ALL BRANCH ACCOUNTS SHOULD BE EXAMINED BY A CHARTERED OR CERTIFIED ACCOUNTANT UNLESS EXEMPT IN ACCORDANCE WITH NATIONAL CIRCULAR NUMBER 362 OF 1991 – as follows:-

- (a) A Branch may appoint, as an alternative to a qualified auditor/independent examiner (or firms thereof) two or more persons who are not Chartered or Certified Accountants to audit the Branch Accounts in any one year. PROVIDED THAT:-
in the preceding year of accounts its receipts and payments did not in aggregate exceed £15,000.
(The amount for Legion goods may now be deducted when establishing the aggregate.)
- (b) It is important to note that Branches who qualify will be permitted to appoint, as an alternative, two or more unqualified auditors as heretofore specified. Further, if in the opinion of the Central Committee a proper examination has not been carried out by such unqualified persons, a Branch can be directed to appoint at its own expense, a Chartered or Certified Accountant (or firm thereof) to re-examine the accounts for the year in question.
